# Evaluation and Accreditation of Higher Education Institutions

### Certified Evaluation and Accreditation (CEA)

Institutional evaluation of education and research activities at higher education institutions

- NIAD-QE, certified by the Minister at the Ministry of Education, Culture, Sports, Science and Technology (MEXT), conducts CEA of universities, colleges of technology and graduate law schools.
- Each university/college must be evaluated at least once every 7 years.
- Each graduate law school must be evaluated at least once every 5 years.
- CEA by NIAD-QE began in 2005 and is now in its 3rd cycle.

### National University Corporation Evaluation (NUCE)

NUCE is a performance-based evaluation of national university corporations based on their medium-term objectives and plans, and their annual plans for education, research and management.

NIAD-QE has been commissioned by the MEXT's NUCE Committee to undertake the evaluation of attainment of medium-term objectives for education and research. The evaluation also takes into account the results of an analysis of the current condition of the faculties and academic units of graduate schools.



### **Awarding of Academic Degrees**


# NIAD-QE provides alternative ways for individuals to earn academic degrees, based on their learning outcomes.

NIAD-QE awards bachelor's, master's and doctoral degrees to those who demonstrate acquisition of academic ability equivalent to that achieved in undergraduate or graduate education. As provided in the School Education Act, NIAD-QE is the only entity besides universities that is authorized to confer degrees in Japan. Since it was introduced in 1991, a total of 83,745 individuals had received NIAD-QE's academic degrees through April 2019. NIAD-QE has two schemes for learners to earn academic degrees.

### Scheme 1

NIAD-QE awards bachelor's degrees to learners who have accumulated credit hours as non-matriculated students at universities, and who have demonstrated academic attainment equivalent to the knowledge and skills required to complete an undergraduate program.


### Special Provision for Awarding a Bachelor's Degree from NIAD-QE

In April 2015, NIAD-QE introduced a special provision on the evaluation of academic attainment for the awarding of academic degrees to students who are scheduled to complete an advanced course at a junior college or college of technology recognized by NIAD-QE.

#### Scheme 2

NIAD-QE awards bachelor's, master's and doctoral degrees to those who successfully complete a university-equivalent program at NIAD-QE recognized educational institutions.

# Research is conducted by the Research Department for the development of quality assurance and degree-awarding.

The Research Department plays the central role in conducting basic research that is the foundation of NIAD-QE's tasks: higher education quality assurance, academic degree awarding and quality assurance cooperation. The Department also conducts applied research to verify these tasks and research focusing on policy issues related to quality assurance. To achieve this aim, the Department carries out joint research projects with other departments and divisions of NIAD-QE.

The research and analysis findings are made widely available through journals/articles and reference documents including data for practical use by higher education institutions.



### Research Journal and Reports

NIAD-QE publishes an annual academic journal 'Research on Academic Degrees and University Evaluation'.

The results of research projects are shared in research reports, seminars and study meetings.



Activities to consolidate and maintain education and research environment, and to improve financing and management of National University Corporations and related institutions

These loans and grants are made available to National University Corporations, Inter-University Research Institute Corporations and the National Institute of Technology to help properly equip the facilities of these institutions.

### Loans for Facility Construction

NIAD-QE lends funds to National University Corporations and Inter-University Research Institute Corporations for improvement of hospital facilities and relocation of campuses. The Minister at the Ministry of Education, Culture, Sports, Science and Technology (MEXT) selects appropriate projects.

### Grants for Facility Construction

NIAD-QE provides grants to National University Corporations, Inter-University Research Institute Corporations and the National Institute of Technology to help renovate facilities. The Minister of the MEXT also selects appropriate projects.

### Repayment of Inherited Debts

As a go-between for universities and the government, NIAD-QE collects debt payments from National University Corporations with hospitals, and reimburses the Ministry of Finance. These debts are remains of those based on the previous Special Accounts for National Schools.

### Management of Inherited National University Properties

NIAD-QE manages national university properties which were inherited from the government. The proceeds are used to fund the facility construction of National University Corporations.

# NATIONAL INSTITUTION FOR ACADEMIC DEGREES AND QUALITY ENHANCEMENT OF HIGHER EDUCATION (NIAD-QE)



NIAD-QE is an incorporated administrative agency created in 2016 by the Japanese Act of General Rules for Incorporated Administrative Agency and the NIAD-QE Act. NIAD, which was established as an academic degree-awarding institution in 1991, was renamed and reorganized in 2000 as the National Institution for Academic Degrees and University Evaluation (NIAD-UE): Their new function was evaluating universities. On April 1, 2016, NIAD-UE and the Center for National University Finance and Management (CUFM) merged to form NIAD-QE. On September 1, 2019, the National Information Center for Academic Recognition Japan was established within NIAD-QE as Japan's official national information center (NIC).
