### 2009: a summer of reports on quality

- No systemic failure of standards and/or quality
- More work needed to provide clear information about quality and standards
- Move to comparing academic standards
- Congruence on external examiners



# The future of the quality assurance system in England and NI: key principles

- Provide authoritative, publicly accessible information on academic quality and standards
- Command public, employer and other stakeholder confidence
- Meet the needs of funders, autonomous institutions and students
- Rely on independent judgement
- Support a culture of quality improvement in HEIs
- Work effectively and efficiently



# Towards a new method of institutional audit

- To commence in 2011
- Autumn 2010 QAA's consultation on method including on
  - Comparability of standards
  - Accuracy and completeness of information about provision, quality and standards
  - Flexibility of audit methods and cycle
  - Language and how we communicate with the public
  - Student centred approach
- Review of the Academic Infrastructure



#### Student centred

- Supporting greater student engagement in quality assurance processes
- Using new methods of communication eg pod casting and films
- Responsive to student requirements for information



### Investigating complaints

• Causes for concern – the current position

• More robust ways of investigating concerns



### Becoming more public facing

- Providing better information on quality and standards
- New methods of communication
- The information we provide:
  - Is it what people want from us?
  - Is it helpful?
  - It is appropriate for the audience it is aimed at?
  - Are we aiming at the right audience?
  - How can we improve?



# The challenges of the international education context

- Supporting international students in the UK
- Promoting understanding of UK approaches to quality and academic standards
- Assuring the provision of UK higher education delivered outside the UK



### Responding to the international context

- Supporting mutual understanding
  - Participation in networks
  - Partnerships, projects and cooperation
  - Testing and verifying information
  - Engaging with stakeholders
- A strategy on cross border education
- The audit of overseas provision

- Graduate employability
- Retention rates
- Learning and teaching styles on the course
  - How will I be taught and supported?
  - How will I be assessed?
  - Who will be teaching me?
  - Opportunities for placements?
